CURRENT ACTIVITIES

Project Design

The design team continued schematic design and met with the project executive team several times during January. User groups from administration/planning, police, and fire functions were identified and provided to the design team. User groups provide internal stakeholders an opportunity to provide the design team with input on their specific needs and requirements.

CM | GC Scoring - Recommendation

Proposals from three CM | GC proposers were evaluated and scored by the project scoring committee on January 19, 2022. Adroit Construction, the contractor for the Civic Center building was selected as the highest scorer. Proposals were also received by S&B James Construction, and Gerding Builders. Temporary Relocation Plan

A plan that outlines several options for relocating city functions during project construction was prepared. The plan will be presented to the City Council for their consent next month.

Other Project Activities

The Geotechnical consultant was given a notice to proceed and the survey is scheduled to begin in February.

- The geotechnical survey was not completed in January due to the unavailability of drillers. It should be completed in February with the report due in early March.
- Design user group meetings will be conducted in February.
- The relocation plan will be presented to the City Council for consideration in February.
