## A. Administrator Reports - copies on file

-Principal Jessica Rojas stated the front office construction is complete and looks amazing; the elementary modular has been delivered; and the intercom system and new clock is being installed at the elementary school.

- -The elementary library is unavailable due to furniture and other storage waiting to be moved into the new modular so the classrooms have been utilized for science/library time.
- -Approximately 320 students are enrolled K-5.
- -The elementary staff and students are preparing for Fall Outdoor School, October 11<sup>th</sup>-12<sup>th</sup>.
- -Principal Mary Matocha mentioned there has been a strong start to school with a 4% enrollment increase overall.
- -Middle School sports are busy developing the football, volleyball, soccer, and cross-country teams.
- -Upcoming events include QPR Suicide Prevention and Awareness Staff Training September 22<sup>nd</sup>.
- -High School Principal Ryan Sticka reviewed new staff and beginning of the school year activities.
- -The High School T.A.G. period will be kept this year with 25 minutes per day for support for students.
- -Upcoming high school events scheduled are Ground Breaking Event for the New Middle School Building and High School Gym September 29<sup>th</sup> at the high school; and Homecoming Week October 2<sup>nd</sup>–7<sup>th</sup>. The Serpentine Parade is 2 p.m., Oct 5<sup>th</sup>.

## **B.** Maintenance Report

- -All the buses have been serviced this summer. Bus #2 had metal shavings in the oil and will have a new engine installed.
- -The irrigation pump was replaced along with the pipe.

# C. CTE Report

- -Manufacturing classes are growing. The classes will be touring many local companies including Zena Forest Products, Luthier Production, and Solid Form to see the "real world" work in action. A goal this year is to have participation in the gallery showcase for Woodturners' International Symposium in Portland this year during May 2024.
- -There are new class offerings this year: animal science, with 22 students enrolled; a welding class with 18 students enrolled; Middle School Ag class with 20 students; an advanced AG class with 14 students and two Intro to AG classes with 42 students. FFA classes will move the greenhouse waterline(s) and get the hydroponics systems running.
- -Construction Trades II class currently has two students and the Trades I class has about the same number of students as last year.
- -The construction classes used the school's sawmill to cut walnut and pine 2x material for use in the shops. One log yielded approximately 310 board feet of 2" thick by 17" wide walnut boards that would cost at least \$1,300.
- -Trades II students are rebuilding and repairing the school solar kiln to dry the material. Jed McMullen will come in next week to talk about solar power for the fans in the kiln.

### D. Superintendent Report

-The new fueling stations are being reviewed for the installation, along with the additional hardware and software for monitoring/billing. There is a 1K gal. diesel tank and a 500 gal. unleaded gas tank.

-Skip Hamilton, HMK, discussed the reason for sole source as we look for options to save money. Sole source allows for standardized systems to minimize spare parts costs and aids in consistent training.
