QUESTIONS AND CLARIFICATIONS

Question: Will the District consider proposals from firms other than Architectural Design Professionals?

Answer: Yes, the District will consider proposals from both *Architectural* Design Professionals and other Design Professionals with consideration of the requirements laid out in the RFP.

Question: Page 5 of the RFP states, “The original Certificate of Understanding of Request for Proposals (ATTACHMENT B) shall be signed with blue ink.” Is a wet signature with blue ink required, or would an electronic signature with blue ink be sufficient?

Answer: Electronic is acceptable provided the firm recognizes it as an official signature.

Question: Page 5 of the RFP states, “Responses including cover letter & resumes are limited to 30 pages of content, single-sided, 8 1/2” x 11”, and minimum 11-point font. Any additional information deemed appropriate should be submitted as a separate document on a separate flash drive. Cover Page, Back Page, Dividers, Resumes, Attachment B, and Attachment D are not considered in the 30-page limit. Are resumes to be included in the page count?”

Answer: Resumes do NOT count towards the 30-page limit as stated in Section 2.1.D.1.
